## **General Information**

- 1. Law n° 6/ 2017 (Control of cross-border transportation of cash and bearer negotiable instruments) imposes no restrictions to bringing in to Macao Special Administrative Region (MSAR), or taking out, any type or amount of physical currency or bearer negotiable instruments. The reporting requirement is solely for the purpose of prevention of money laundering and terrorist financing as part of the international effort to combat those crimes.
- 2. Travellers bringing in to MSAR currency or bearer negotiable instruments equal to or exceeding MOP 120,000.00, or its equivalent in another currency, are legally bound to declare it. On departure from MSAR, submission of declaration form is required only if the traveler is called upon to do so by the customs officer.
- 3. Bearer negotiable instruments means any monetary instruments, such as travellers cheques and negotiable instruments that are either in bearer form, endorsed without restriction, made out to a fictitious payee, or otherwise in such form that title thereto passes upon delivery and incomplete instruments (including cheques, promissory notes and payment orders) signed, but with the payee's name omitted.
- 4. The details of carried cash, currencies and or bearer negotiable instruments must be declared in Part II of this form. Should the values belong to third parties, the traveler must identify those persons in Part III.
- 5. All written information provided in this declaration must be true and complete. Non-declared or false or incomplete information provided is considered an administrative offence subject to a fine of 1% to 5 % of the amount exceeding the designated amount, but never less than MOP 1,000.00 and not more than MOP 500,000.00.
- 6. The data contained in the declaration is protected under Law n° 8/2005 (Personal Data Protection Law); however, it may be accessed by judicial authorities for purposes of criminal investigation only, pursuant to criminal law and criminal procedural law.
- 7. This form is issued free of charge. When filling the form, tick appropriate boxes with " $\checkmark$ ". If more than three items are carried, the necessary additional forms should be filled in.
